4	A 3.300 overall College GPA is required at the time of graduation. Even if a thesis is submitted well in advance of graduation, a 3.300 GPA at the time of graduation is a requirement.

All committee members must be from the IU-Bloomington campus. The thesis committee has to be formed nester prior to graduation.

A 3-5 page summary of the thesis project should be presented to the committee prior to the meeting and signed by the committee after the meeting. This summary will then be submitted to the Biology Undergraduate Advising Office by the committee chair.					
7	A physical copy of the honors thesis must be provided to the committee no later than April 15 (for May graduates) or December 1 (for December graduates).					
	a.	The thesis must follow the general format of a journal article (Introduction, Material and Methods/Procedures, Results, and Discussion/Conclusions).				
	b.	References to all sources must be included with format following that of a journal in the field of study relevant to the thesis topic.				
	c.	While no absolute length requirement is in place, the suggested minimum length is 25 pages, double-spaced, 12 pt. font (any standard font such as Times, Arial, Helvetica), and 1" margins.				

¹ In some rare cases, MSCI-M 450 or CHEM-X 399 may be used in place of BIOL-X 490 upon written permission of the Director of Undergraduate Studies. If MSCI-M450 or CHEM-X 399 is approved, it may not be mixed with BIOL-X 490 for purposes of honors requirements. If a student is working in a Psychology Department lab, BIOL-X 490 is required.
